CfY is a youth mentoring program that offers opportunities for students to create a sense of community and belonging in a safe and supported environment. The program promotes positive identity, development of leadership and voice, setting goals, challenging oneself, development of social emotional skills, and civic engagement. Mentors receive four weeks of orientation and monthly training on Critical Mentoring, race, culture, identity, establishing rapport, goal setting, graduation requirements, and the mentor's role in supporting cultural integration. The match starts with Launch, an outdoor adventure experience that students and mentors complete together to make connections and begin to form relationships. At Launch, students (and mentors) give their top three choices for a match. CfY prioritizes student choice in making matches. Students and mentors then meet weekly one-on-one, in family groups of 5-7 pairs, and/or as a Learning Community with up to 40 pairs.

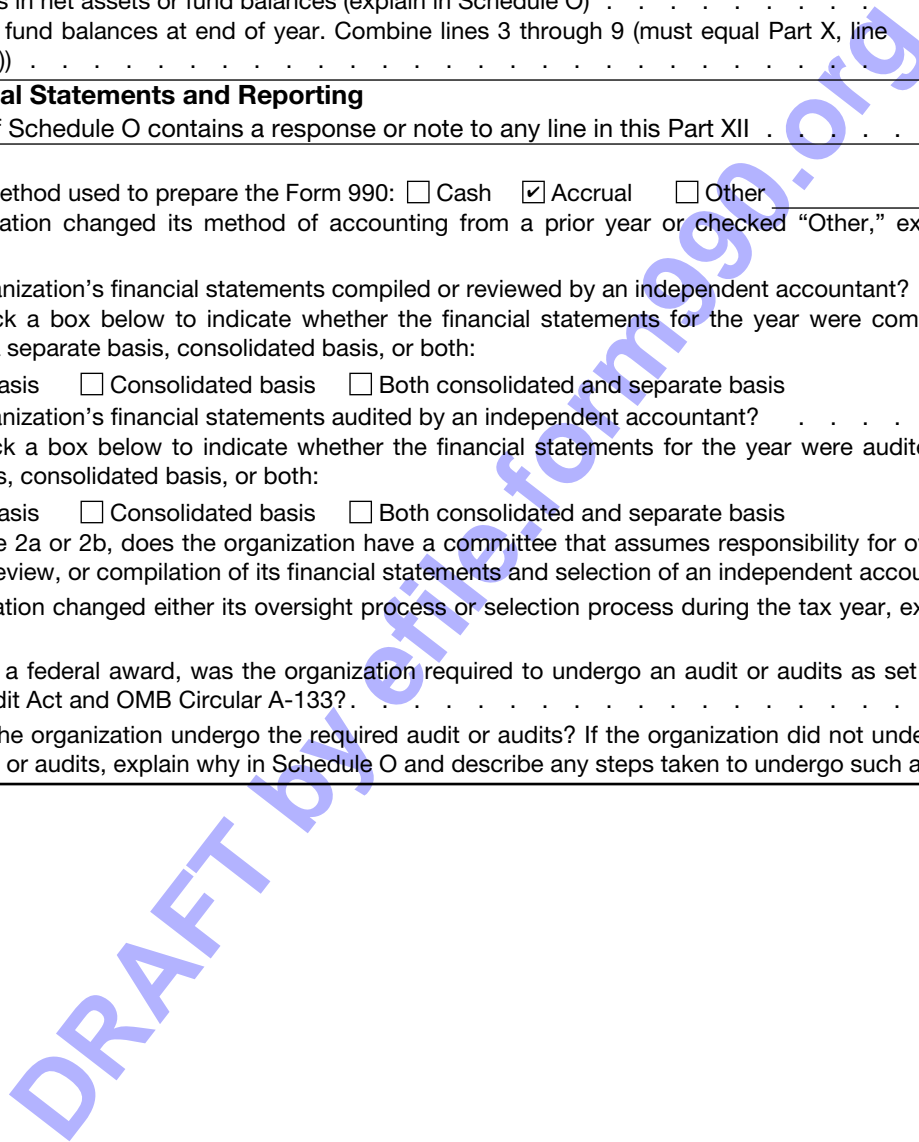
